PRIVACY POLICY ON PERSONAL DATA PROCESSING

GDPR 679-2016

Data controller

The data controller is the company Life Source Srl, with its registered office at Largo Porta Nuova 12 - 24122 Bergamo and operating headquarters in Via Briantea, 5 24129 Bergamo and identified in the person of the owner and legal representative who implements all available solutions to guarantee the security, confidentiality and protection of personal data processed.

Purpose

This information, referred to in article 13 of the GDPR 679-2016, concerns the processing of personal data of subjects participating in the program called "Life Source Club" and the management of what it provides, only and exclusively, the program itself that the subject receives in file and/or paper format of which he declares to view it. The information and data provided will be processed in compliance with GDPR 679-2016 and based on the principles of correctness, necessity, proportionality, legality and transparency to protect confidentiality, security, protection and exercisable rights.

Processing methods

Personal data are processed with electronic and/or automated tools and in manual, paper mode or without the aid of electronic tools. The provision of personal data is essential to provide the service offered. The failure to provide personal data to Life Source Srl prevents the provision of the service referred to in the "Life Source Club" program.

Authorised entities or categories of authorised entities and security measures

The data provided are in no way subject to dissemination and are processed by the staff of Life Source Srl appropriately trained and instructed for this purpose. They are also processed exclusively in compliance with the provisions of GDPR 679, even by subjects responsible for processing where this is necessary for the sole purposes set out in this notice. The data are stored and kept safely in the same structure where the activity is carried out, in the cloud by the software house referred to the management system adopted if processed electronically and protected by software solutions for the purpose adopted.

Data storage

The data collected are stored in paper and electronic files with controlled access and in any case protected by physical and computer solutions to ensure their security, confidentiality and protection.

Data communication

The data shall not be disclosed to any other party.

Exercise of the rights

At any time, the data subject may exercise, pursuant to the articles listed below of EU Regulation 679, the right to:

- obtain access to their personal data, be informed about the processing and receive a copy thereof (Art. 15);
- obtain the correction of inaccurate personal data concerning him (Art. 16);
- obtain the deletion of their data without undue delay ("right to be forgotten") (Art. 17);
- obtain the restriction of processing (Art. 18);
- obtain the portability of personal data in a structured format, in order to transmit them to another holder (Art.20);
- oppose the processing of data (Art. 21).

The data subject has the right to withdraw consent at any time, if this is the basis of the processing, without prejudice to the lawfulness of the processing based on consent given before the revocation. The data subject may exercise his or her rights by contacting the data controller using the following contact details indicated in this document.
