

PRIVACY POLICY ON THE PROCESSING OF PERSONAL DATA "WEB"

Personal data processing obtained from the contact generated on "lifesource.it"

Art. 13 of GDPR 679-2016

Life Source Srl, as Data Controller pursuant to EU Regulation 679/2016 invites you, before communicating any personal data to the Data Controller, to carefully read this notice because it contains important information on the protection of your personal data. We anticipate to you that the processing of your data is linked to the requests that you will make to us and in the legitimate interest of Life Source for the offer of the services proposed by our facility. His data will not be disclosed.

Data controller

The data controller is Life Source Srl, with its registered office at Largo Porta Nuova 12 Bergamo and its operational headquarters at Via Briantea, 5 Bergamo.

Purpose

This information concerns the processing of personal data voluntarily communicated through the contact form of our website. The provision of Your Personal Data is always optional, however, in the absence of these in the contact form it will not be possible to provide You with useful answers about our services. The processing of your data is exclusively linked to the requests that you will make to us and in the legitimate interest of Life Source for the offer of the services proposed by our facility.

The information and data provided will be processed in compliance with GDPR 679 and will be based on the principles of correctness, necessity, proportionality, lawfulness, and transparency to protect confidentiality and exercisable rights, as well as the principle of accountability set forth in Article 5 of the GDPR.

Methods of processing

Personal data are processed with electronic and/or otherwise automated tools and in manual and paper mode.

Recipients - Persons or categories of authorized persons and security measures_

The data conferred are not disseminated in any way and are processed by the appropriately trained staff of "Life Source" for the purpose authorised with specific IT network access profiles in relation to their roles or by any appointed external processors who will comply with the provisions of the EU REG 679. The data are kept physically secure and if processed electronically protected by software solutions adopted for the purpose.

Data retention

The data collected are kept in paper and electronic archives with controlled access (files with lock or password) and in any case so that third parties cannot access them and for a period referred to by the laws of purpose.

Data communication

Yours data will not be disclosed or communicated to third parties.

Exercise of rights

At any time, the interested party may exercise, pursuant to the articles below of EU Regulation 679, the right to:

- obtain access to your personal data, be informed about the treatments and possibly receive a copy of them (art. 15);
- obtain the rectification of inaccurate personal data concerning him (art. 16);
- obtain the deletion of your data without unjustified delay ("right to be forgotten") (art. 17);
- obtain limitation of treatment (art. 18);
- obtain the portability of personal data in structured format, in order to transmit them to another owner (art.20);
- oppose data processing (art. 21).

The data subject has the right to withdraw consent at any time, in case this forms the basis of the processing without prejudice to the lawfulness of the processing based on the consent given before
